Below are the required clearances that we request be submitted with the application:

- 1. All applications should be accompanied by a PA Criminal Background Check and PA Child Abuse History Clearance. This is a requirement for both head and assistant coaches.

- 2. An application must be submitted each year for the PA Criminal Background Check and the PA Child Abuse History Clearance is valid for a period of Three (3) years.
- 3. If a volunteer has lived outside of the Commonwealth of PA in the last 10 years, a fingerprint-based federal criminal history (FBI) must be submitted through the PA State Police or an authorized agent
  - a. Volunteers that are serving in an unpaid capacity and have lived withing the Commonwealth of PA for the past 10 years do not need to obtain the FBI clearance.
